WHEREAS, the Wayne County Commission approved Resolution No. 2022-906 on November 30, 2022 that authorized a revenue-generating towing services contract with one, two-year option to renew between the Charter County of Wayne and Martin's Towing, Inc. (of Brownstown), as recommended by the Sheriff; and

WHEREAS, the term of the contract was incorrectly stated in Resolution No. 2022-906; and

WHEREAS, the correct term of the contract was from November 30, 2022 through September 30, 2025.

Now therefore be it

RESOLVED, by the Wayne County Commission this 8th day of January, 2026 that approval be, and is hereby, granted authorizing retroactive Amendment No. 1 to a revenue-generating towing services contract with one, two-year option to renew between the Charter County of Wayne and Martin's Towing, Inc. (of Brownstown) in the estimated amount of \$150,000, exercising the option to renew, to provide the Sheriff's Office with towing, storage and auction services initiated for assistance, abandonment and/or nuisance abatement seizures, as recommended by the Sheriff; and be it further

RESOLVED, that Amendment No. 1 increases the total contract estimated amount from \$150,000 to \$300,000; the term of the contract including Amendment No. 1 is from November 30, 2022 through September 30, 2027 and the revenue will continue to be deposited into Account No. 265 31303 628035 (Sheriff-Drug Enforcemnt); and be it further

RESOLVED, that performance on this amendment was performed prior to Commission approval in violation of Section 120-50 of the Wayne County Procurement Ordinance (Ordinance No. 2006-1101, as amended), and that violation of Section 120-50 may be cause to debar a Person (as defined in Section 120-50) from receiving County contracts; and be it further

RESOLVED, that if the County incurs actual liability, of any kind, the Department of Corporation Counsel shall initiate civil action to recover the County's costs, expenses and damages as set forth in Section 120-50; and be it further

RESOLVED, that the Chief Executive Officer be, and is hereby, duly authorized to execute the aforementioned amendment on behalf of the Charter County of Wayne.

**AMENDMENT NO. 1 BETWEEN
THE COUNTY OF WAYNE AND MARTIN'S TOWING, INC**

THIS AMENDMENT No.1 between the County of Wayne, Michigan, a public body corporate and Charter County acting through its Department of the Sheriff (the "County") and Martin's Towing, Inc. (the "Contractor") amends Contract No. **2022-71-049**, approved by the Wayne County Commission on November 30, 2022, by Resolution No. 2022-906.

RECITALS

The parties entered into a revenue contract to provide vehicle and watercraft towing, storage, redemption, and auction services from November 30, 2022, through September 30, 2025, with one two-year option to renew. The parties desire to exercise the option by renewing the Contract for two years.

IT IS AGREED:

1. Section 5.01 is amended to:

This Contract is effective from November 30, 2022, to September 30, 2025. The parties agree that it is renewed for the term beginning October 1, 2025, and ending September 30, 2027. The Contractor must expediently perform the services to achieve the objectives of this Contract.


