RESOLVED, by the Wayne County Commission this 15th day of April, 2025 that approval be, and is hereby, granted authorizing Amendment No. 1 to a three-year contract with one, two-year option to renew between the Charter County of Wayne and Smart Business Source, LLC (formerly Global Office Solutions, Inc.) (of Troy), with no change in the dollar amount, exercising the option to renew, to continue to provide the County with office supplies and equipment, as recommended by the Chief Executive Officer; and be it further

RESOLVED, that the total contract not-to-exceed amount remains \$4,500,000; the term of Amendment No. 1 is from April 6, 2025 through April 5, 2027 and the cost of the contract will continue to be charged to Account No. various various 730001 (County-wide); and be it further

RESOLVED, that the Chief Executive Officer be, and is hereby, duly authorized to execute the aforementioned amendment on behalf of the Charter County of Wayne.

**AMENDMENT #1**

**THIS IS AMENDMENT #1** to Contract 2022-37-002 between the County of Wayne ("County") and Smart Business Source LLC (d/b/a Global Office Solutions Inc.) ("Contractor"), approved by the Wayne County Commission on April 21, 2022 (Resolution 2022-280).

**RECITAL**

The County entered into a three (3) year agreement for office supplies and equipment with Global Office Solutions Inc. ("GOS") beginning April 6, 2022 and expiring April 5, 2025. Smart Business Source LLC purchased Global Office Solutions effective July 1, 2022, subsequently "doing business as" GOS according to the original agreement. The Contract provides a 2-year renewal option. The parties wish to exercise the two-year renewal option.

**NOW THEREFORE IT IS UNDERSTOOD AND AGREED AS FOLLOWS:**

1. Smart Business Source LLC, f/k/a and d/b/a Global Office Solutions Inc., replaces GOS as party to this Contract, pursuant to assignment of all original contractual obligations, inclusive of the specifications of IFB 37-21-137, including the electronic ordering capabilities outlined in section 3.4.7 of the IFB.
2. The Contract is renewed for two (2) years, beginning April 6, 2025 and ending April 5, 2027.
3. All other terms and conditions of the original Contract shall remain in full force and effect.
4. Each party warrants that its agent signing this Amendment is authorized to bind its principal.
5. This Amendment is subject to the County's policies regarding modification of contracts and is effective upon approval by the Wayne County Commission.
